- 1. Leon Roberts confirmed the presence of a quorum.

- 3. Financial Statements/Approve Expenditures for May, 2015

Dan Redd reported on May Financials and Expenditures. He reported to the Board that the City check for May was \$101,850.42, a 5.28% increase from the same month last year. He also reported cash balances, rent, receivables and expenditures. Dan Redd presented statistics on Unemployment Figures for the Panhandle area for April. Hutchinson County's rate was 3.5%.

- 8. Dan Redd presented the names of Cory Meadows, owner of Kodiak Operating, and Karl T. These names will be presented to the City Council at the next Council meeting to be held on Tuesday, June 16.
